Public Hearings

1. 0 Vine Street, MBTA

Open the Public Hearing on a Notice of Intent, filed by MBTA, Pursuant to Massachusetts General Law, Chapter 131, Section 40-the Wetlands Protection Act, The applicant proposes construction of approximately 4,500 lineal feet of turn-back track adjacent to existing mainline track within the existing railroad right-of-way and existing railroad ballast. Portions of the work are within the Buffer Zone to a Bordering Vegetated Wetland. The application and plans can be viewed during regular business hours at the Town Hall Conservation Office, 16 Lowell Street Reading, MA 01867, and on the Conservation Division page under the project by year, **0 Vine Street (from the Train Station to Willow Street), near Assessor's Map 20, Lot 195 DEP File No. 270-0802**

2. <u>O Small Lane</u>,

Open the Public Hearing on a Notice of Intent, filed Joseph Marino, Pursuant to Massachusetts General Law, Chapter 131, Section 40-the Wetlands Protection Act and/or the Reading Wetland protection By-law, Section 7.1, for proposed tree cutting, limited project roadway crossing, retaining walls, wetland alteration, wetland replication, drainage, to construct a single-family dwelling, porch, walkway, driveway, rooftop infiltration, grading, and associated utilities. All of the work is within the Buffer Zone to a Bordering Vegetated Wetland. The application and plans can be viewed on the Conservation Division page under current project, Assessor's Map 40, 41 Lot 153 & 29, Also 22 Small Lane Map 40 Lot 155, Dep File No. 270-0803

3. 24 Dustin Road

Open the Public Hearing on a Notice of Intent, filed Shawn McSheffrey, Pursuant to Massachusetts General Law, Chapter 131, Section 40-the Wetlands Protection Act and/or the Reading Wetland protection By-law, Section 7.1, for razing the existing home and constructing a new single-family home with associated porch, patio, garage, and driveway. Portions of the work are within the Buffer Zone to a Bordering Vegetated Wetland.
